
## CERTIFICATE

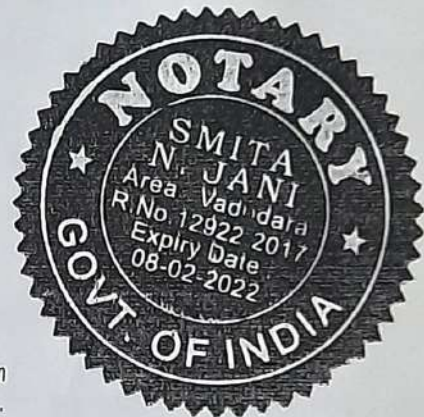
